

## skyticket Points Usage Terms

The skyticket Points Program (hereinafter referred to as the "skyticket Points Program") is a distinctive rewards initiative provided by skyticket, a comprehensive platform for comparison and reservations (hereinafter referred to as the "skyticket website") operated by Adventure, Inc. (hereinafter referred to as the "Company"). This skyticket Points Program is designed exclusively for individuals who are registered members of skyticket Membership (hereinafter referred to as "skyticket Members").

### ARTICLE 1 TERMS OF USE

---

The skyticket Points Terms of Use apply to individuals who have registered as skyticket Members. By registering as a skyticket Member, individuals are deemed to have agreed to these skyticket Points Terms of Use.

### ARTICLE 2 ELIGIBILITY OF SERVICES

---

The Company will award skyticket points to skyticket Members who book qualifying travel services through the skyticket website and subsequently utilize those services, such as hotel stays or boarding a flight reserved via their account. Notwithstanding the aforesaid, this offer excludes payments made through bank transfers, Pay-easy or convenience store transactions. Additional information is provided herebelow.

- a. Services Eligible for skyticket Points  
Flights (air tickets), Flight + Hotel Packages (with only flight fares qualifying for skyticket Points), Domestic Tours (only flight fares qualifying for skyticket Points), select Car Rentals (excluding those paid locally), Ferry and Express Bus Reservation Services available on the skyticket website (including mobile sites and apps)
- b. Services Not Eligible for skyticket Points  
Offline flight bookings (such as telephone bookings made via skyticket Customer Support), direct bookings on partner websites, complimentary bookings, Study Abroad services, travel insurance and any other booking services deemed ineligible by the Company

### ARTICLE 3 SKYTICKET POINTS AWARD INFORMATION

---

1. skyticket Members who book qualifying services will earn a designated number of points based on their skyticket Membership Status after using the service. skyticket Points are granted for every USD100 spent (excluding any fees, taxes or additional charges). For more information pertaining to skyticket Membership Status and the corresponding points awarded, please refer to the information available on My Page.

2. skyticket Points are calculated based on US dollars. Payments made in currencies other than US dollars will be converted to US dollars at the exchange rate in effect at the time of the transaction before determining the number of skyticket Points to be awarded.
3. skyticket Points will be awarded in accordance with the outlined schedule.
  - (1) Air Tickets

skyticket Points will be credited on the first day of the second month following the month in which the flight took place. skyticket Members who book two (2) or more flight routes simultaneously will receive their skyticket Points on the first day of the second month after the boarding date of the final flight route.
  - (2) Hotel Accommodation

skyticket Points will be credited on the first day of the second month following the month in which the checkout occurred. Please be aware that there may be delays in receiving confirmation from the hotel, which could lead to a postponement in the awarding of skyticket Points.
  - (3) Rent-a-Car

skyticket Points will be credited on the first day of the following month that follows the month in which the vehicle was returned.
  - (4) Express Bus

skyticket Points will be credited on the first day of the second month following the travel date. skyticket Members who book two (2) or more express bus routes simultaneously, skyticket Points will be awarded based on the travel date of the final route, following the same timeline.
  - (5) Ferry

skyticket points will be credited on the first day of the second month after the boarding date. skyticket Members who book two (2) or more ferry routes simultaneously, skyticket points will be credited on the first day of the second month following the boarding date of the final route.
4. Taxes may be levied on skyticket points and other benefits granted. In the event that such taxes are imposed, skyticket Members shall be liable for these taxes, including any related disclosure obligations.
5. skyticket Points will not be granted for canceled reservations of services that qualify for skyticket Points, as the service has not been utilized. If a reservation is canceled or changed via a method other than through the skyticket website, and skyticket Points have already been awarded before the cancellation is acknowledged by the Company, the awarded skyticket Points will be deducted from the skyticket Points balance of the skyticket Member.

#### ARTICLE 4     USAGE OF SKYTICKET POINTS

---

1. skyticket Members can utilize their skyticket Points at any time within the validity period, redeeming them at a rate of 100 skyticket Points for USD1. This can be applied towards the total or partial payment of the reservation service fee on the skyticket website, which includes the skyticket Handling Fee. In cases where fees are not listed in US dollars, the conversion will occur based on the exchange rate applicable at the time of the transaction. skyticket Points will not be earned on payments made using skyticket Points.
2. The Company reserves the right to limit the use of skyticket Points for specific reservation services or to establish conditions for their application. skyticket Members can verify the availability of skyticket Points on the skyticket website payment screen. In instances where multiple reservation services are utilized simultaneously, skyticket Points will be allocated equally across the services.
3. When utilizing skyticket Points, priority will be given to skyticket Points that are closest to their expiration date. If multiple skyticket Points have the same expiration date, they will be applied in a specific, predetermined sequence as outlined herebelow.
  - a. Limited-time skyticket Points awarded through promotional campaigns
  - b. skyticket points earned through reservations
4. The Company retains the authority to deny and/or restrict skyticket Members from utilizing skyticket Points or to revoke any reservations made with skyticket points if there are suspicions of unauthorized or inappropriate use. Additionally, the Company may terminate a skyticket Membership if it determines that the extent of unauthorized use is substantial.
5. skyticket Members are not permitted to modify or cancel the number of skyticket Points utilized once they have been redeemed.
6. skyticket Members who decide to cancel reservations made with skyticket Points will have the skyticket Points deducted based on the exchange rate in effect at the time of the reservation. If the cancellation fee is lower than the total skyticket Points utilized, and those skyticket Points remain valid, the excess skyticket Points will be credited back to the skyticket Points balance of the skyticket Member. Importantly, the expiration date of any returned skyticket Points will remain unchanged.
7. The Company will not issue refunds for any skyticket Points that were applied towards the payment of a reservation, regardless of the circumstances, once a skyticket Member has actually used the booking service on the skyticket website.

#### ARTICLE 5     CANCELLATION OR EXPIRATION OF SKYTICKET POINTS

---

1. The Company reserves the right to revoke skyticket Points awarded to skyticket Members if deemed necessary, such as in cases of reservation service cancellations, system malfunctions or erroneous point allocations. Should skyticket Members have utilized these skyticket Points prior to their revocation, they will be obligated to reimburse the equivalent

- value of the used skyticket Points through a method designated by the Company.
2. The Company retains the authority to establish the duration for which skyticket Points remain valid and these points will automatically become invalid once the designated validity period has lapsed.
  3. The Company shall not provide any compensation or assume any responsibility for skyticket Points that have been canceled or expired, except in cases where there is a reason attributable to the Company for such cancellation or expiration.
  4. In the event that a third party uses the ID and password of a skyticket Member to redeem skyticket Points, the Company shall not be held liable for the recovery or compensation of those skyticket Points, except in cases where the Company is directly accountable for the situation.

#### ARTICLE 6 SKYTICKET POINTS MANAGEMENT

---

1. skyticket Members can view their skyticket Points, check their usage status, see the available skyticket Points and skyticket Member statuses by accessing My Page on the skyticket website.
2. skyticket Members are prohibited from transferring, lending or permitting third parties to utilize their skyticket Points or any rights related thereto.

#### ARTICLE 7 SKYTICKET POINTS PROGRAM CHANGES, SUSPENSIONS AND/OR TERMINATION

---

The Company reserves the right to modify or discontinue the skyticket Points Program at any time for operational purposes. This may include adjustments to the redemption rate for skyticket Points, the criteria for earning or using skyticket Points, the services that qualify for skyticket Points accumulation and any other necessary alterations.

#### ARTICLE 8 REDEMPTION OR EXCHANGE

---

The Company will not exchange skyticket Points for cash under any circumstances, including when a user (skyticket Member) decides to discontinue their use of the skyticket website or in the situations outlined in the preceding Article 7.

#### ARTICLE 9 SKYTICKET POINTS ALLOCATION BY THE COMPANY

---

In the event that a skyticket Member causes damage to a third party through intentional or negligent acts, including unauthorized cancellations related to travel or other services booked via the skyticket website, and skyticket compensates the third party for such damages, the company reserves the right to utilize the skyticket Points of the skyticket Member to cover the costs of these damages. The conversion of skyticket Points will be based on the exchange rate applicable at the time of the payment to the third party.

#### ARTICLE 10 OTHERS

---

Any matters related to the allocation and utilization of skyticket Points on the skyticket website, along with other matters not explicitly addressed in this skyticket Points Usage Terms, will adhere to the usage rules outlined on the skyticket website, including those found on the reservation confirmation screen of this service.

#### ARTICLE 11 AMENDMENTS / REVISIONS TO SKYTICKET POINTS USAGE TERMS

---

1. The Company reserves the right to amend, revise and/or modify these skyticket Points Usage Terms at any time without prior notice to skyticket Members and/or users.
2. In the event that the Company amends or revises these skyticket Points Usage Terms, the revised terms shall govern the use of the skyticket Points Program. Unless otherwise specified by the Company, the updated Terms shall be available on the skyticket website at least 15 days prior to their effective date, and such posting shall serve as notification to skyticket Members and/or users.
3. The Company shall not be held liable for any disadvantages or damages incurred by skyticket Members and/or users as a result of modifications to these skyticket Points Usage Terms.

#### ARTICLE 12 DURATION OF SKYTICKET POINTS PROGRAM

---

The skyticket Points Program is scheduled to commence in July 2025, with the conclusion date yet to be established. The Company retains the authority to discontinue the skyticket Points Program at any time. In the event of termination, skyticket Members will have a thirty (30) day grace period to redeem their accumulated skyticket Points from the date of announcement. After this period, any unutilized skyticket Points will be rendered invalid, and no compensation will be provided.

#### ARTICLE 13 GOVERNING LANGUAGE OF SKYTICKET POINTS USAGE TERMS

---

This document serves as the English translation of the original skyticket Points Usage Terms, which are provided in Japanese. In the event of any discrepancies or inconsistencies between this English version and the original Japanese text, the Japanese version shall take precedence and be considered the authoritative source.
